The Paul Pesthy Memorial Super Youth Circuit will be held in the San José Convention Center, March 27–28, 2010. The website is www.gofencing.com/SYC2010.

The entry form can be printed and completed with a pen, or can be filled in on the computer, then printed and signed, it can also be emailed, provided that the payment is received by March 7, 2010. Online registration and credit card payment with a deadline of March 7, 2010 is available at www.gofencing.com/SYC2010.

All fencers whose birth year has not been verified by the USFA will need to show a birth certificate or other government–issued identification with a birthdate before they fence in their first competition of the tournament.

All entries will receive a confirmation within 1 week of receipt of the entry form. **Keep this page for your records;** if you do not receive a confirmation, please contact us by email at sycwest@earthlink.net or by phone at (858) 731 0832.

The division of membership and ratings for all fencers will be verified with the USFA as of March 5, 2010. If there is any discrepancy between what the fencer provides on the entry form and what the USFA has recorded, we will contact you at the email address and/or telephone number on the entry form. All ratings used in the competition will be those from the USFA roster as of March 10, 2010.

The competitions on Saturday, March 20 are Youth 14 Epée, Youth 10 Epée, Youth 12 Foil, Youth 14 Sabre and Youth 10 Sabre. The Competitions on Sunday, March 21 are Youth 12 Epée, Youth 14 Foil, Youth 10 Foil and Youth 12 Sabre. Close of check in times will be posted on the website and are subject to small adjustments up to March 1, 2010.
